The company commits no material mistake, decay, rotting, cracking in the product for 2 years.

1- If a deficiency occurs within the warranty period, the buyer must complete the warranty support request form and notify Hasoğluwood company. If it is found that the defect is caused by defect, production workmanship or quality of material after examining the representative authorized by the company, the sole responsibility of the Hasogluwood - KANENZO brand is the replacement of defective profiles or profiles with new ones. (Shipping, installation and installation costs do not belong to my company). We declare that our company can change with the closest color, design and design, but that it does not undertake a one-to-one pairing by taking into consideration that the color, design and design of the previously purchased material may change according to the conditions of the color, design and design of the materials to be replaced.

2- The fittings and accessories used during assembly are not covered by the warranty.

3 - Any rights arising from this contract can only be used by the buyer and our company. The transfer of these rights to third parties is certainly not possible.

4. Our company is not responsible for any damage or defect caused by the disassembly and assembly of the materials of the company except the assembly address stated in the purchase contract.

5- This warranty covers replacement of the defective product with a new one. Employment related to the installation of materials, such as transportation, etc. Costs do not cover and our company is not responsible for them.

6- Within the first 3 months after the application, changes in color tone within the tolerances on exposure to sun are not covered by the guarantee.

Exposing material belonging to my company indirectly or directly to extreme heat source, digging, shovel, ice shovel, drill, knife etc. Damages arising from sharp edges, cutting and puncturing materials, damage caused by excessive weight on or over the material, or abrasive materials such as chemical materials, paints and varnishes are not covered by the guarantee. Our products are not designed to carry loads. The steps specified in the installation specifications must be applied with care and the damage that may occur after mounting should be minimized. After product assembly, strength test should be done.

Our company does not guarantee the following conditions and it is unthinkable that no tangible guarantees cover these situations:
